BRE is a PBIS School



PBIS stands for Positive Behavior Intervention Support. It is a program developed to address negative behavior and create a positive atmosphere where student's positive behavior is rewarded.

BRE is a GOLD LEVEL Tier 1 Model PBIS School for the 2019-2020 school year. We have given our school a new fresh look to promote our GOLD LEVEL status. As part of some of the new revisions, we have added CHAMPS, an evidence-based behavior program, to support teachers with effective classroom management by educating students about appropriate behaviors and attitudes expected in the classroom, during special area times and in the cafeteria.

- C- Conversations: Can students talk to each other?
- H- Help: How do students get their questions answered?
- A- Activity: What is the task or objective?
- M- Movement: Can students move around?
- P- Participation: How do students show they are fully participating?
- S- Success: A student SOARs by following CHAMPS expectations!

Our PBIS committee has also revised our Cardinal Coins whole class reward program to encourage positive behavior in Special Area classes as well as the in the cafeteria and on the bus. Each class will have the opportunity to receive a Cardinal Coin every day the class displays appropriate behavior during lunch and in their Special Area classes. Once each class receives 40 coins, the classroom receives a class reward.
